**Directions:**

*From KS Turnpike (I-35) South:* Exit Wichita East (Kellogg). Go East on US54 for 11.5 miles (Mile Marker 233).

*From KS Turnpike (I-35) North:* Take Andover Exit, go right (east) for 4 miles to Santa Fe Lake Rd, turn right (south) go 3 miles to US Hwy 54, turn left (east) & go 1.3 miles. Farm on left at Mile Marker 233.

*From I-35 North:* Take Exit 10 (K-96) go approx. 9 miles to US Hwy 54 (Augusta), east approx. 9 miles.
